APPROVAL OF JUNE 5, 2024 MEETING MINUTES:

PROGRAM UPDATES:

Julie Fuentes-TOP started with 19 students and ended with 12 participants. Had a celebration and received a \$100 stipend. They met 50 times over the school year. Completed service-learning projects. All students were taken to the Department of Health. STOP-All-Star's Celebration and collaborated with All-Star's Plus. Helped with field day and donated corn-hole. Sources of Strength-Had a pep rally and highlighted sources. Conducted a presentation at Ocotillo Elementary with the 5th graders.

Isaac Florez-Discussed that they are patrolling at the beach. Joana brought up the concern that last weekend there was a car show at the beach and a WIPP party as well as the waterpark and Isaac was the only patrolman on duty with thousands of people present. This is a safety concern for our community. Isaac stated they are cracking down on overtime and others were comping their time. SRO's are going to hopefully get an advanced training in Texas before the next school year.

Hannah Ornelas-Discussed Teens in Action having the Summer Challenge again. This is posted on social media. Teens can take a picture of being active in our community and posted it, tagging the Coalition to win a gift card. At the end of June we want to have an event at the mini golf. June 21 we will team up with the Library to help with their movie night and provide popcorn and snacks.

Esther Hernandez-We held a Round Table discussion at the college. We invited 28 stakeholders but only 10 were able to come. The discussion was about underage drinking. This summer we are going to work on recruiting for Teen Court and have a future training.
